The course proceeds for 2.7km miles to the finishing point shown in image 3

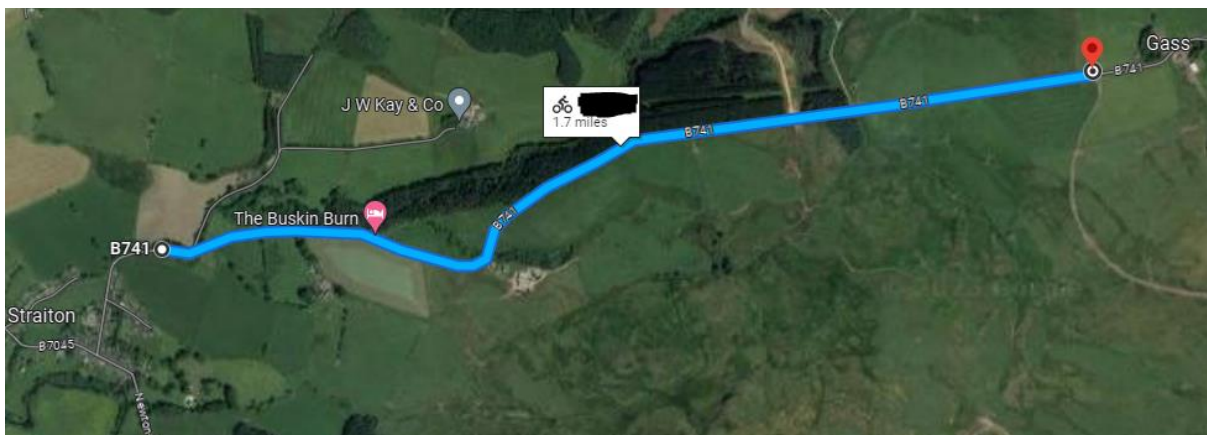

## Finish

The race ends at the top of the hill with the timekeepers positioned in the layby on the opposite side of the carriageway. (see images 2 and 3)

### Traffic Flows:

No traffic flow changes to accommodate the event and there will be no significant impact to other road users during the event. The event is on the Lambdoughty Hill to the east of Straiton village and does not require riders to turn off onto other roads as part of the race, minimising the road risk.
