

## West DC: Risk Assessment

**Cycling Time Trials – West DC** Course Risk Assessment Document. The measures to reduce risk identified in the right hand column must be included on the start sheet or implemented for the duration of the event as applicable. Failure to comply with the requirements of this document may result in approval being withheld with respect to subsequent race promotions by the promoting club. #### **Course Description:**

Starts in Staunton and Corse om B4208 in lay-by just north of the junction with Straight Lane. Follow B4208 through Pendock to Cramer's Green. Turn sharp left at Cramer's Green and follow minor road to T-junction with A417.Trace A417 back to Staunton and Corse. At the miniroundabout, go straight on and then turn immediately left onto B4208 to complete one circuit. Three circuits in total.

## **Traffic Flows:**

Traffic counts performed on the course on 4th September 2022 (Sunday morning).

09:10 – 09:20: Northbound (outbound) = 138 units/hr; Southbound (return) = 156 units/hr

09:30 – 09:40: Northbound (outbound) = 126 units/hr; Southbound (return) = 216 units/hr

### **Course / Event History:**

This course has been used as a club TT course for many years (at least 3 races per year for the past 10 years). UC101 is a 9.6 mile loop called 'The Pendock Loop' and is usually raced over 1, 2 or 3 laps.
