- Start on Askham road at junction with unnamed road leading to Lowther Castle and Gardens.
- TAKE CARE with Sheep, also please be aware of the 2 Cattle Grids & the steep descent from the start in Lowther Park
- Proceed along Askham lane in a westerly, then southerly direction
- Marshal 1 Bear right over Askham bridge and then to 'T' junction in Askham (1.1m).
- Marshal 2 Turn left onto Helton road
- Bear right (1.3m) onto Wideworth Farm road.
- Continue through Butterwick and Bampton on unclassified road to meet Keld lane then Pow lane on the outskirts of Shap.
- Marshal 3 Take a sharp left to join A6 North (8.9m).
- Marshal 4 Continue on A6 to Lowther (14.5m) where left into New Road
- Continue to finish 50m before Junction (14.9m)

- The following local regulations have been approved by the CTT National Committee in accordance with Regulation 38. Any breaches may lead to disciplinary action being taken.
- Local regulation No. 5 In all events, competitors prior to starting are not permitted to ride past the finish timekeeper during the duration of the event.
- Local regulation No. 6 Any competitor making a 'U' turn in the vicinity of the start or finish will be disgualified from the event.
- Local regulation No. 15 Riders must keep to the left hand side of the road except when overtaking. Failure to comply with the above may lead to disqualification.

In addition to the above

- Riders must give their number at the finish and elsewhere on the course if requested.
- Riders must NOT stand in the road at the start or finish.
 - o (This constitutes obstruction, and is a breach of regulations).
- Riders must NOT ride with their heads down.

Helmets

- All competitors under the age of 18 and/or juniors must wear a HELMET of
- HARD/SOFT SHELL construction that conforms to a recognised Standard (See regulation 15).
- Cycling Time Trials strongly recommends ALL competitors to wear such a helmet.
- Cycling Time Trials recommends that a working rear light, either constant or flashing, is
 fitted to the machine in a position clearly visible to following road users and is active
 while the machine is in use.
