Main Gate) Proceed eastwards on B4265 through Gileston cross roads (1.962 miles). Continue down the hill to cross over the River Thaw bridge (2.95 miles) and continue on B4265 climb the hill to "BA Maintenance Depot" roundabout (5.104 miles). Encircle roundabout taking 5th exit to retrace along B4265 to Gileston Cross Roads (8.366 miles) to continue on B4265 to FINISH at point 8 yards beyond '50' road sign, at field entrance on left (10.006 miles) and 591 yards before reaching Start point.
