However Cycling Time Trials Regulations provide that a copy of the form should be sent to the Secretary of each District Council in whose area the event passes to arrive not less than 42 days before the date of the event. It is recommended that the Notice should be sent to the Chief Officer of Police at this time rather than immediately prior to the expiry of the statutory 28 days.
