




# NOTICE of proposed CYCLING TIME TRIAL

(Section 31 ROAD TRAFFIC ACT 1988)

Cycle Racing on Highways Regulations 1960 (S.I. 1960, No. 250)

<p><b>START</b> on south side of A163, approx. half mile west of Derwent Bridge (Bubwith), at western side of driveway to Derwent Cottage Farm (paint mark on road). <b>PROCEED</b> west, via North Duffield, South Duffield crossroads (2.04 mls) to Traffic Island at junction with A19 (Barlby north) – 4.24 mls. <b>TURN LEFT</b> (1<sup>st</sup> exit) and proceed south on A19 to Barlby South Traffic Island (junc. A63) – 5.15 mls. <b>ENCIRCLE ISLAND</b> (CARE!!) and retrace north on A19 to Barlby North T.I. – 6.16 mls. <b>TURN RIGHT</b> (2<sup>nd</sup> exit) on to A163, and proceed via South Duffield crossroads (8.40 mls), and North Duffield, to <b>FINISH</b> at mile stone "Selby 6, Weighton 12" on north side of A163, 580 yds before entrance to Duffield Carrs car park – 10.00 mls.</p>

<p><b>NOTE TO PROMOTING SECRETARY:</b> After completion by the Promoter this form must be lodged with each appropriate Chief Officer of Police <b>within whose area any portion of the route traverses</b>, not less than 28 days before the date of the event. However Cycling Time Trials Regulations provide that a copy of the form should be sent to the Secretary of each District Council in whose area the event passes to arrive not less than <b>42 days</b> before the date of the event. It is recommended that the Notice should be sent to the Chief Officer of Police at this time rather than immediately prior to the expiry of the statutory 28 days.</p>
